SCDMH is the leading School Mental Health Services provider across South Carolina. We provide school age children diagnosticservices, interventionservices, and arange of treatments including individual, group, and family therapy.

TelePsychiatry

SCDMH is the largest provider of telepsychiatry, and telehealth, services in the state. The Program continues to expand in its scope and provides approximately 2,000 psychiatric services per month. Services are available 18 hours per day.

Peer Support Programming

Peer Support Specialists add an additional layer of support in the treatment process. They use recovery tools, personal recovery stories, and community networking to assist peers in recognizing the opportunities of living the life they wish to live.

Office of Deaf Services

A statewide system of care for the delivery of mental health services which promote recovery and allow enhanced mental functioning for Adults, Children and Families where Deafness presents a significant cultural and/or linguistic barrier.

Multilingual Mental Health Services

SCDMH has systems in place to communicate with people whose first lanuage is not English. These systems consist of phone services, web based information, documentation forms, educational materials, and clinical services as part of our commitment to serve all people in South Carolina.

Emergency Services& Crisis Care

First Responder Support Team (FRST)

Our FRST Program offers specialized mental health services designed to assist first responders and their families. We understand the public nature of these positions and offer services in a highly confidential environment.

Mental Health Courts

SCDMH works in partnership with the legal system across South Carolina to provide Mental Health Court services - a diversion program designed for mentally ill defendants arrested for misdemeanor and non-violent felony offenses.

Mobile Crisis

SCDMH Mobile Crisis clinicians provide 24 / 7 / 365 day community based crisis response anywhere in South Carolina. Our goal is to provide patients throughout the state with immediate access to crisis services and the most appropriate level of care.

Office of Suicide Prevention

The Office of Suicide Prevention (OSP) works to address the issue of suicide through extensive training, awareness, and collaboration with other state agencies, nonprofits, communities, and medical and behavioral health care systems.
